Notice of Public Hearings

The Law Reform and Development Commission (LRDC), in conjunction with the Electoral Commission of Namibia (ECN) and the Namibia Institute for Democracy (NID) has initiated an Electoral Law Reform Project (ELRP), under the Law Reform and Development Commission Act, 1991 (Act No. 29 of 1991) aimed at consulting stakeholders and the public on issues pertaining to electoral reform. Consultation meetings and public hearings have therefore been initiated and will be conducted countrywide, resulting in a draft report on suggestions for electoral law reform, to provide the basis for the drafting of a new electoral bill.
